Conference Title: Exploring New Paths in Graduate Education

President's Report

The President of the Conference of Southern Graduate Schools (CSGS), John Kiss, called the annual business meeting to order at 12:30 pm.

Secretary's Report

The minutes of the 44rd Annual Business Meeting held in New Orleans at the InterContinental New Orleans Hotel on March 7th were placed in each attendee's program materials. A motion was made and seconded to accept the minutes. With no deletions, additions, or modifications, the minutes were approved.

Treasurer's Report

A. Sustich delivered the Treasurer's report pointing out the deficits that we have been accruing during the past two years. He made comparisons between last year and this year explaining that our dues level does not cover our expenses. The Treasurer's report covered the period of January 1, 2015 to December 31, 2015. There was a beginning cash balance \$96,313.68 compared with last year's cash balance of 114,504.38. Our total revenue this year was \$119, 843.06 compared with last year's at 89,082.23. Our total expenses were \$142,398.88 giving us a net loss of \$22,696.32. Our cash balance is 73,617.36 and this compares with last year's ending cash balance of 96,313.70.

Proposal to raise dues (from \$150 to \$150-\$250)

President J. Kiss introduced the motion to raise the dues from \$150 to a tiered system beginning with \$150 for institutions with graduate enrollments up to 999, \$200 for institutions with enrollments between 1000 and 3999, and \$250 for institutions with enrollments greater than 4000 graduate students. A motion was made and seconded to endorse the new dues structure. A vote was taken and the motion passed unanimously.

Audit Committee Report

B. Melhart reported that after a review of the finances of the organization, the committee found no discrepancies and that the revenue and expense statement accurately depicts a healthy financial situation.

Faculty Awards Committee Report

B. McNamara reported on the two CSGS faculty awards. After introducing the committee members, he gave background information on the evaluation of the

awards. There were 11 nominees for the mentor award and 4 nominees for the contributions award. The winners were:
